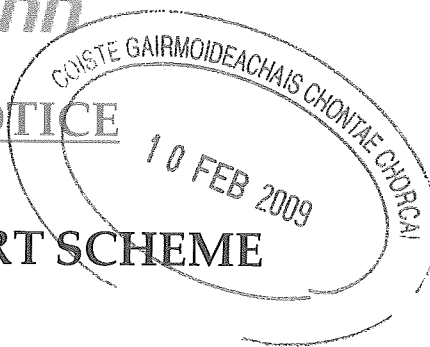

SCHOOL TRANSPORT SCHEME

REVISED CHARGES & TICKETS FOR SCHOOL YEAR
2009/2010

The following is the charging system that will apply for the 2009/2010 school year:-

PUPIL CATEGORY	ANNUAL CHARGE
ELIGIBLE POST PRIMARY	€ 300
CONCESSIONARY POST PRIMARY	€ 300
CONCESSIONARY PRIMARY	€ 200
MAXIMUM FAMILY CHARGE	€ 650

Eligible Post Primary pupils from families with medical cards will continue to be exempt from charges.

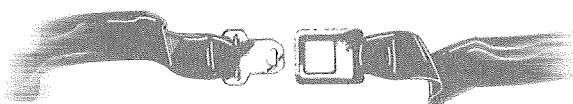
The amount due may be paid in full on or before the 31st July 2009, in which case an Annual Ticket for the full school year will be issued. Alternatively, 50% of the annual amount due may be paid by the deadline date of 31st July 2009, in which case a ticket valid for travel up to 22nd December, 2009 will be issued. In this instance the balance due must be paid by 4th December 2009. Upon receipt of this payment a second ticket, valid for travel up to the end of the school year in June 2010, will be issued.

NO TICKET – NO TRAVEL
PUPILS WILL NOT BE ALLOWED TO TRAVEL UNLESS THEY ARE IN POSSESSION OF A VALID SCHOOL TRANSPORT TICKET.

LATE APPLICATIONS/LATE PAYMENTS
PUPILS MAY NOT GET A SEAT IF THEIR APPLICATION AND/OR PAYMENT ARE RECEIVED AFTER THE DEADLINE DATE OF 31st JULY 2009.
